

HOUSE RULES.....SALINAS POST 31

1. To avoid suspension of lounge privileges, members and guests must comply with all Post rules and regulations.
2. Nobody under 21, without special dispensation by the Commander, will be allowed in the lounge after 7 p.m.
3. Gambling for money in the lounge is prohibited.
4. Employees will not be allowed to drink alcoholic beverages while on duty.
5. Employees, members, and guests will pay with cash or equivalence for all drinks and sundry items bought in the lounge.
6. To be admitted in the lounge, guests must be signed in by a member. Member will be responsible for the conduct of his guests. No member shall be allowed to sign in more than four (4) guests at one time. Guests must depart when, or before, the host member departs.
7. Members shall not reprimand employees of the post but shall submit all complaints or suggestions in writing to the Post Commander through the Adjutant.
8. No alcoholic beverages will be permitted in/on the post premises except as provided by the liquor license.
9. Post 31 will not be responsible for articles lost or stolen.
10. Except for seeing-eye dogs, no animals will be allowed in the post premises.
11. Members and guests will conduct themselves at all times as ladies and gentlemen, which means refraining from the use of vile or abusive language and from engaging in physical violence.
12. Members and guests suspended (excused) from the lounge by the bartender on duty for violation of Post rules **and an incident report has been filed**, shall remain suspended (excused) until the Executive Committee meets at its regular monthly meeting and determines how much longer the suspension shall last.
13. The bar and related facilities will be closed during Post 31 membership meetings and during such other times as the Commander will designate. All drinks must be cleared from the bar at least ten (10) minutes before the meeting.
14. At any meeting of Post 31, the commander will excuse any member he considers to be "under the influence." If any such member refuses to be excused, he will be reported to the Executive Committee for appropriate action.
15. Normal civilian clothes may be worn at the Post day or night. Other clothing may be worn on those occasions where a costume is considered appropriate. Military clothing is permissible at all times. Those wearing clothes with vulgar or obscene words or graphics will be asked to leave the premises immediately.
16. Any member of the Post 31 Legion family guilty of cashing a bad check shall have his/her lounge privileges suspended until such time as the check is made good. A second violation shall result in permanent suspension of check-cashing privileges. A person's check-cashing limit will be \$50.00 per shift. There will be a \$20.00 surcharge on every bad check cashed. (Only members of the Post 31 Legion family may cash checks.)
17. Lounge hours shall be posted at both main entrances to the lounge.
18. There shall be no smoking within the Post 31 building.
19. The Executive Board may change the House Rules when deemed appropriate.
